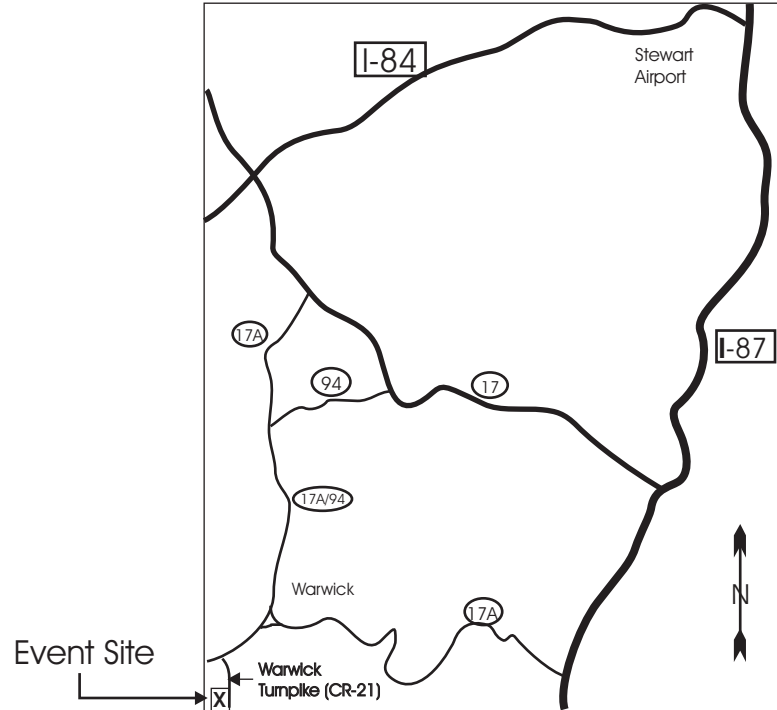

Directions to the trial

From Albany (or from the North)

- Take I-87S towards NYC to Exit 17 (to I-84)
- Take I-84W to Middletown, NY to exit 4E (to Rte 17 to NYC)
- Take Rte 17 to exit 124 (to Florida, NY).
- Turn left at the end of the ramp onto Rte 17A.
- Follow Rte. 17A /94 through Florida, NY and Warwick, NY
- Pass the Warwick Valley Country Club on your right.
- Continue on for approx. 1 mile.
- Turn left onto Warwick Turnpike/CR21 (plaza on left)
- Look for a sign on the right side about 1 mile up the road.

From NYC

- Take I-87N to exit 17 (I-84) & follow above.
